Terms of Reference:

- The Committee shall oversee selection process of the private party (in terms of the PPP Act, 2010) for the project.
- The Committee may extend the date in respect of any activity of the Project Timeline in accordance with the provisions of Sindh Public Procurement Rules, 2010 as amended time to time.
- The Committee shall review and approve the Bidding Documents/Request for Proposal (RFP), draft Concession Agreement, Project Brief, Information Memorandum and any other document, for the purpose of issuing the same to the prospective bidders, by the Procuring Agency.
- The Committee shall be responsible for the technical & financial evaluation of the Proposals/Bids.
- The Committee or its authorized representatives may, if the need be, hold pre-bid conference and address queries of the bidder leading to finalization of the RFP and draft Concession Agreement & Bidding Documents.
- The Committee shall approve the preferred bidder for issuance of Letter of Intent (LOI) by the procuring agency for contract negotiations.
- The Committee shall recommend the preferred bidder to the PPP Policy Board for award of the contract and signing of the Concession Agreement by the procuring agency under the applicable rules & acts.
- The Committee shall review financing documents and financial security arrangements at the time of financial close.
- The Committee shall perform any other task assigned to it by the PPP Policy Board in the context of this project.
