**Terms of Reference:**

- 1) The Committee shall oversee selection process of private partner (developer for the project).
- 2) The Committee may extend the date in respect of any activity of the project Timeline in accordance with the provisions of Sindh Public Procurement Rules, 2010.
- 3) The Committee shall pre-qualify the bidders, on the basis of Evaluation Criteria issued to them for issuance of bidding documents.
- 4) The committee shall review and approved the bidding documents such as Evaluation (selection) Criteria, Request for Proposal (REP), Concession Agreement, Project Structure, Financial Model and Project Information Memorandum or any other documents, for the purpose of issuing the same to the bidders by the Procuring Agency i.e. Works and Services Department;
- 5) The committee or its authorized representative may, if there need be, hold pre-bid conference and contract negotiations with the Bidders and address query of the bidder leading to finalization of the REP and Draft Concession Agreement.
- 6) The Committee shall recommend the preferred bidder to the PPP Policy Board for issuance of letter of intent by the procuring agency;
- 7) The committee shall review and approve financing documents and financial security arrangements at the time of financial close that might be required by any of the finding parties.
- 8) The committee shall perform any other task assigned to it by the PPP Policy Board Sindh in the context of this project. Moreover TFEC shall be authorized to perform any task it deems appropriate to facilitate/execute the project, specific approval of which may not be required by the PPP Policy Board.
- 9) Quorum: Sixty percent participation of the members shall constitute quorum of the Committee.
